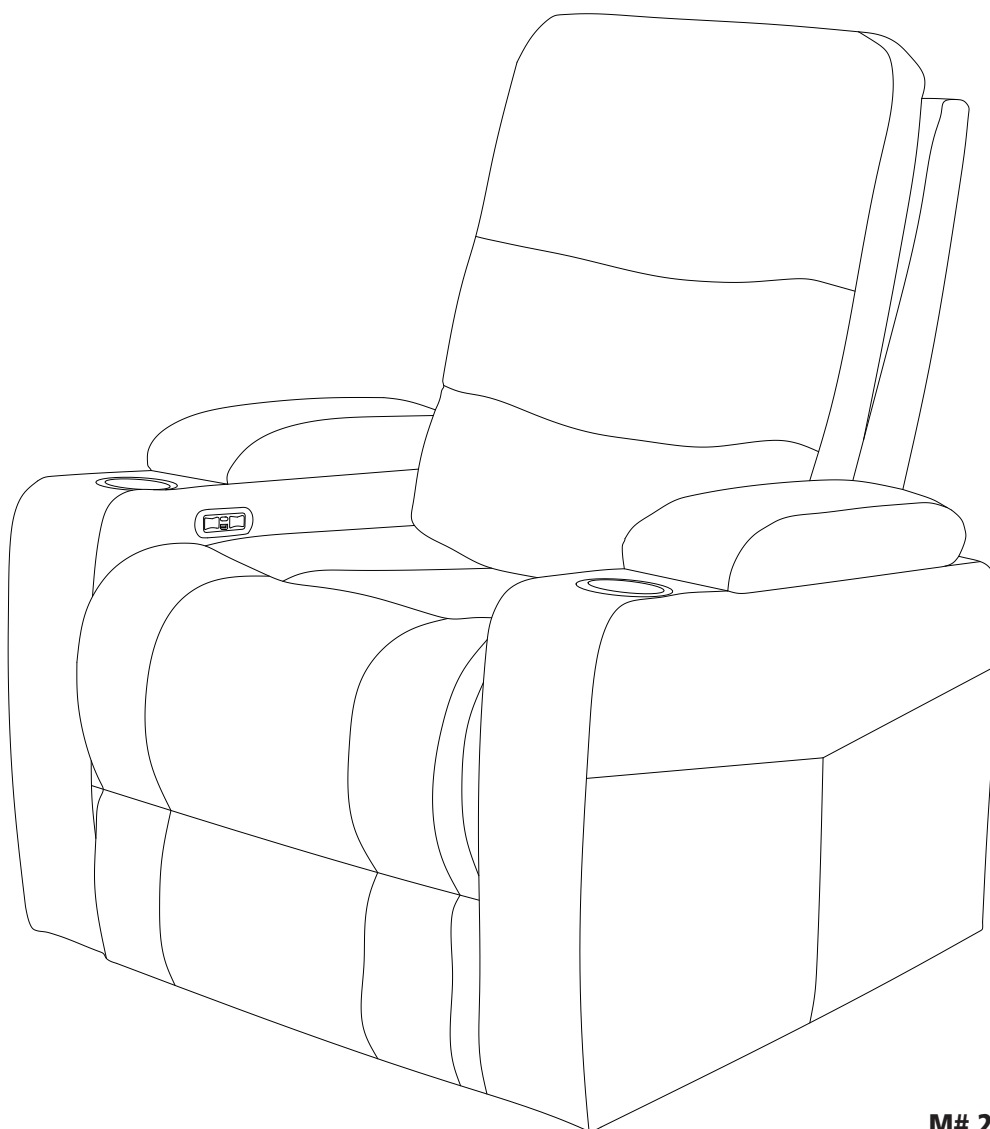

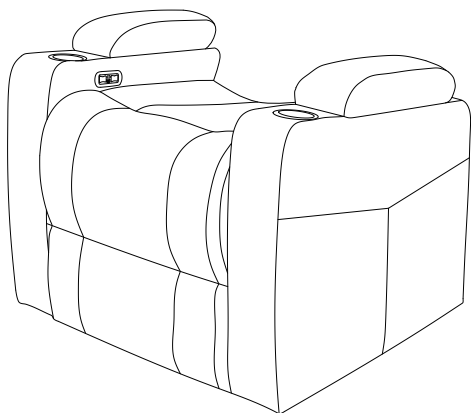
## Before Assembly

- *Remove all parts and hardware from the box. Place all items on a carpeted or scratch-free work surface, as this will avoid damaging parts during assembly.*
- *The shipping box provides an ideal work surface.*
- *To avoid accidentally discarding small parts or hardware, do not dispose of any packaging or contents of the shipping carton until assembly is complete.*
- *Use the parts and hardware lists below to identify and separate each of the pieces included.*
- *The use of power tools for assembly is not recommended. Power tools can damage the hardware and/or split the wood.*

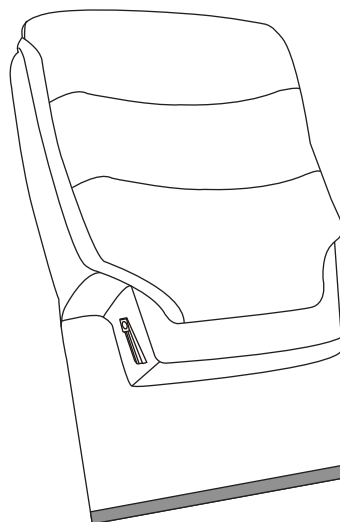
## Care and Cleaning

- *Dust often and use a vacuum cleaner crevice tool to clean seams. To maintain the appearance, gently clean soiled areas with a soft cloth dampened with a mild, water based detergent. Remove all lather and wipe with a clean damp cloth. Dry with another soft cloth by blotting the damp surface (do not rub).*
  - *Do not place furniture in direct sunlight and keep furniture at least 60 cm / 2 ft from heat sources to avoid fading.*

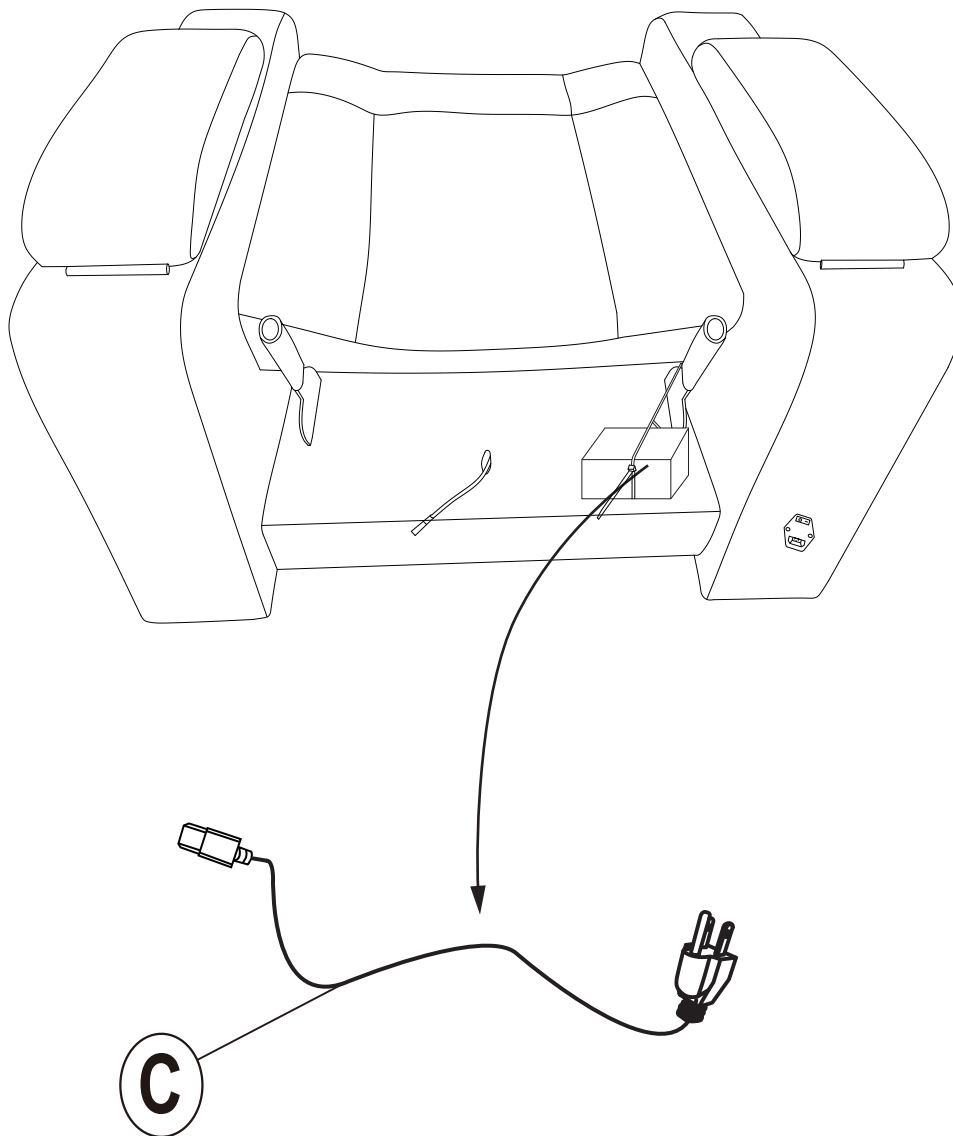

## Attention:

# Assembly Instructions

## Step 1

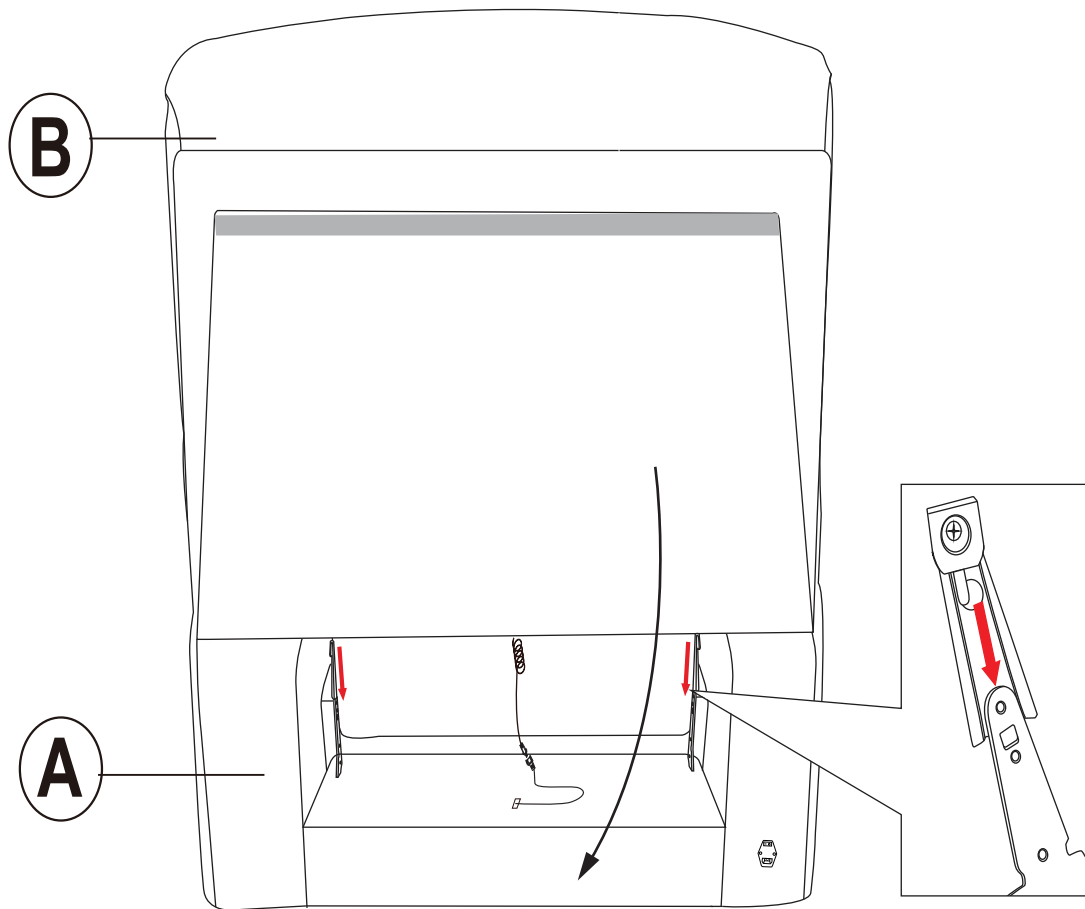

Tack out seat base (A) and back (B) from the carton and tack out power cord carton from back of seat base(A) as shown, then tack out the power cord from the carton. Final, separate all parts into part number groups as indicated in the parts list.

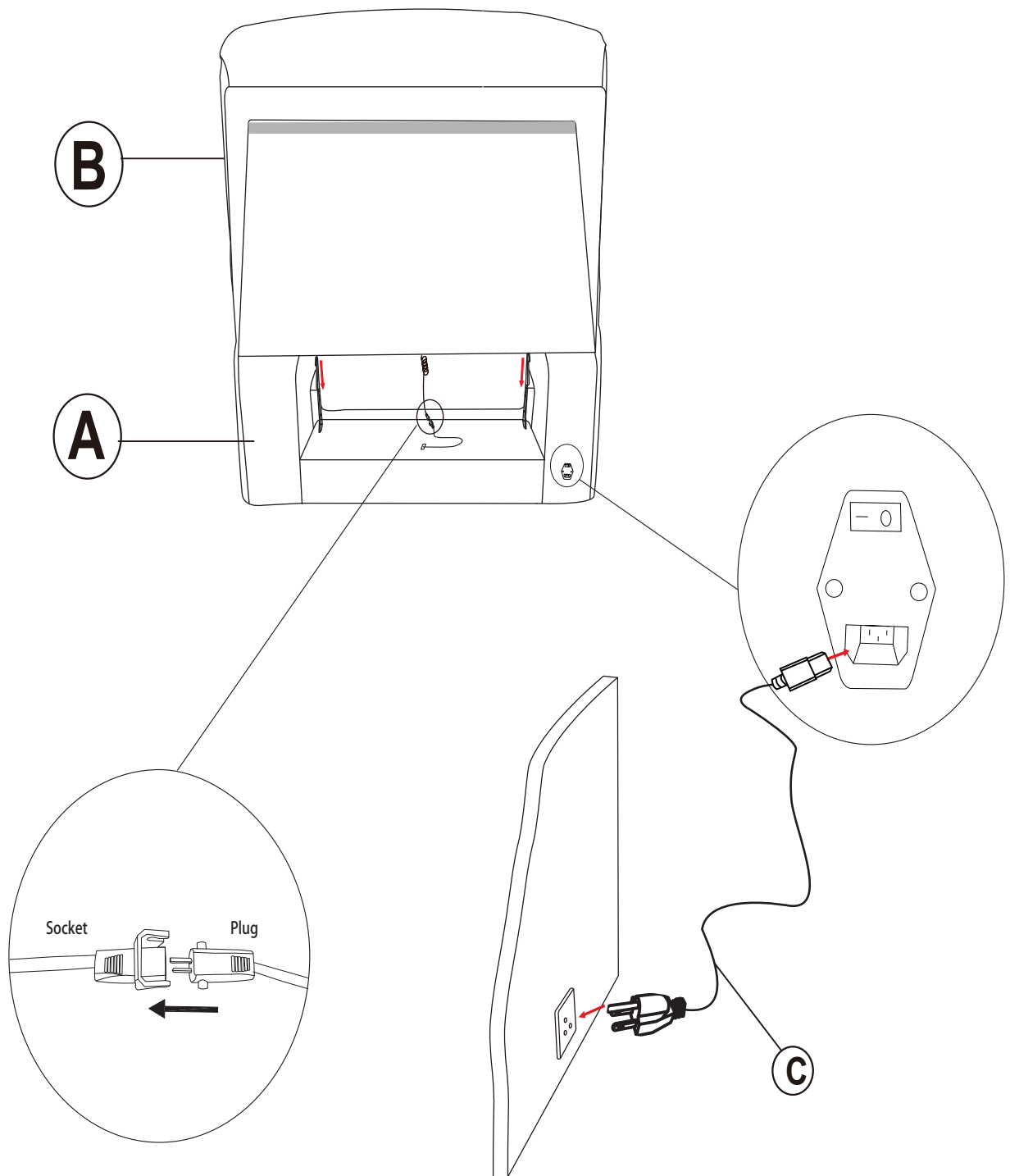
## Step 2

Attach the Back (B) to the Seat base (A) by sliding the receivers into the mechanism posts located on the Seat base (A). From the front of the recliner, press down on both sides of the Back (B) to firmly secure. The Back (B) and Seat base (A) will automatically lock into place. Then pull the back flap down tightly and attach the back flap to the bottom of the Seat base (A).

## Step 3

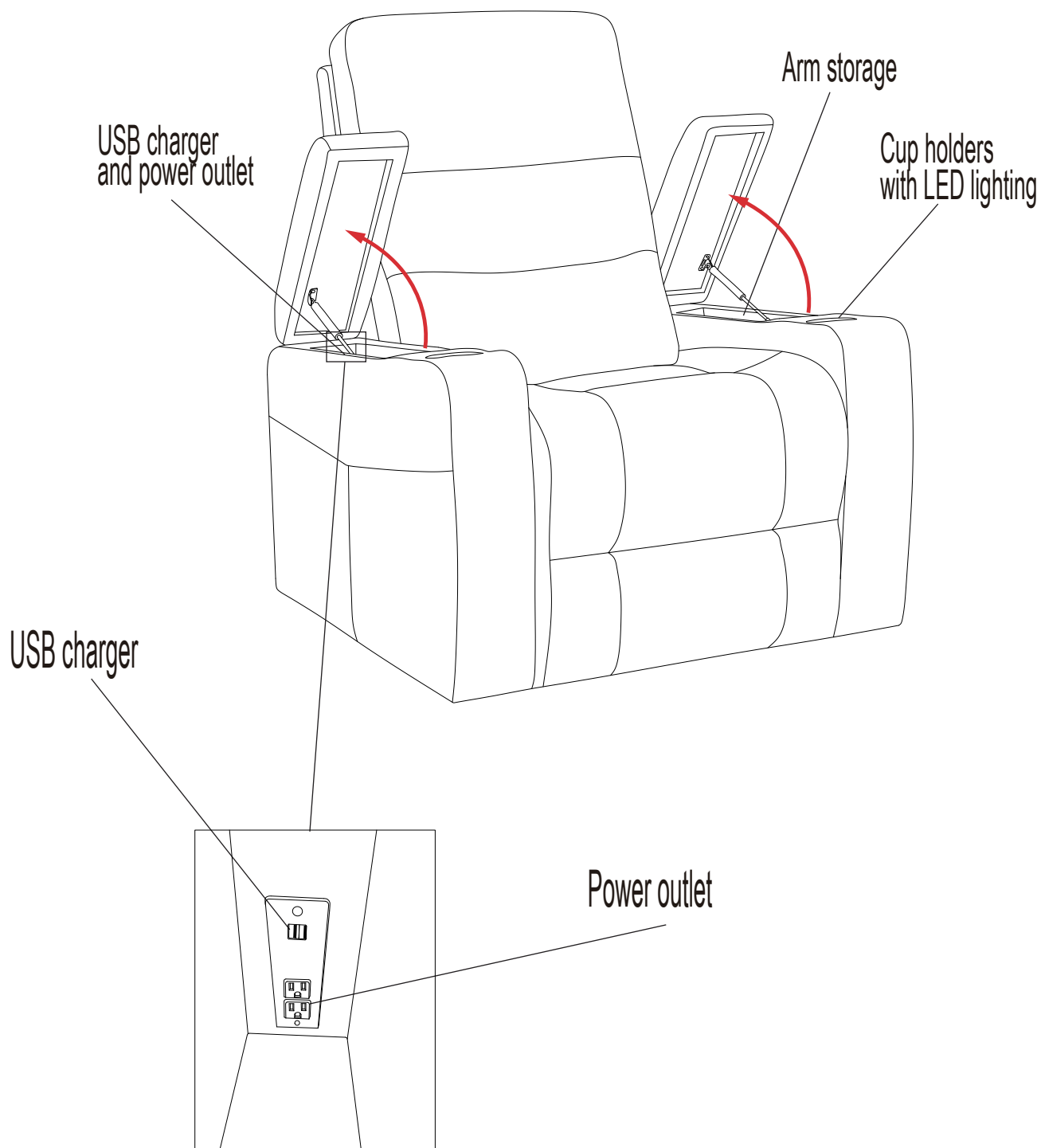

First, connect the connector between the back (B) to the bottom of the seat base (A). Then, one end of the power cord (C) is connected to the seat base (A), and the other end is connected to the socket-outlet (110V-240V) after removing the plastic cap from the plug. When the power switch is pressed to the "—", it means it is on, and when it is pressed to the "O", it means it is off. Then pull the back flap down tightly and attach the back flap to the bottom of seat base (A).

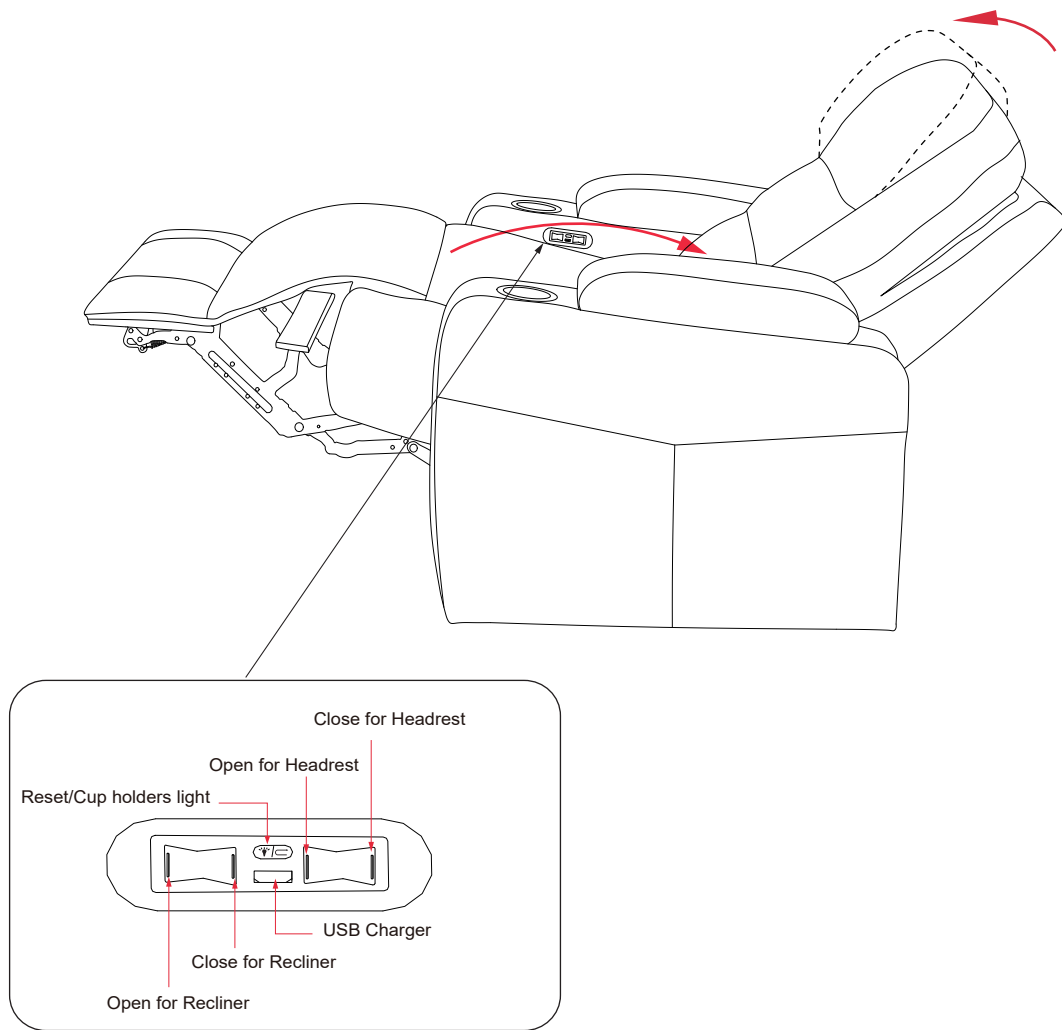
NOTE: The socket-outlet shall be installed near the equipment and shall be easily accessible.

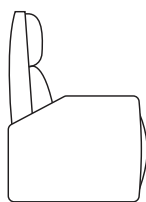

While seated, enjoy the recliner as the shown.

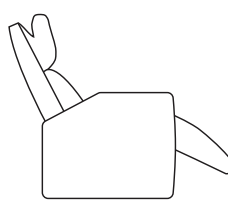

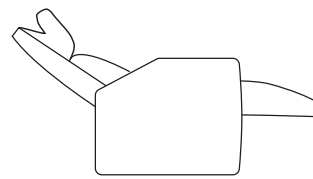
While seated, press the "Cup holders light" control button on the right arm to open the cup holder lights, press the "Open for Recliner" control button on the right arm to make the back cushion recline so it will move backwards. Press the "Open for Headrest" control button on the right arm to adjust headrest. To close the cup holder lights, return the back cushion and pillow to your desired position, press the "Cup holders light", "Close for Recliner" and "Close for Headrest" control button. You can also long press the "Reset" control button to get it back to original position. The electric mechanism can provide you with the most appropriate angle to make you relax. Please remove and put away power cord when it is not in use.

In the event of a defect in material or workmanship covered by this warranty, True Innovations will repair or replace, at their discretion, without charge the warranted furniture within a reasonable amount of time. Natural markings such as scars, brands, grain variations, wrinkles, color variations, etc., will be considered normal characteristics and not construed as defects. We cannot warrant leather against scratching or scuffing, as all leather is subject to blemishes with use.
